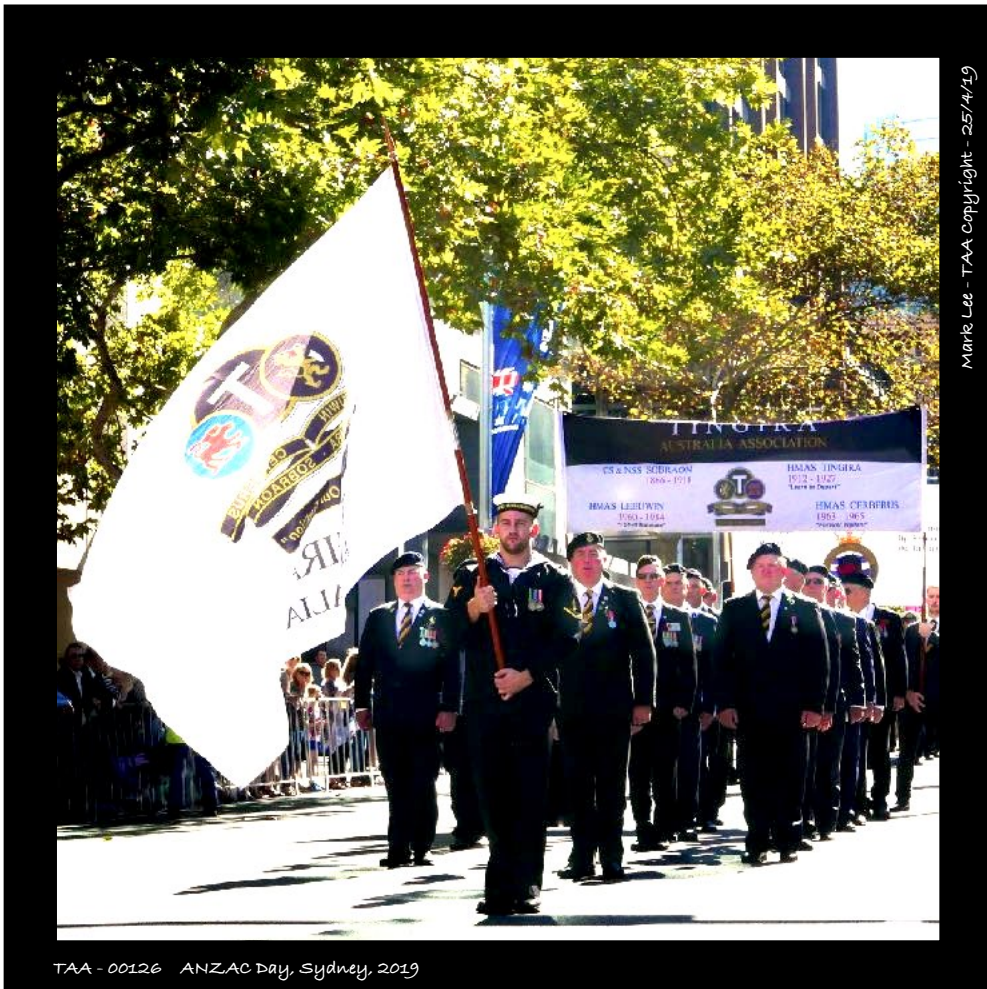

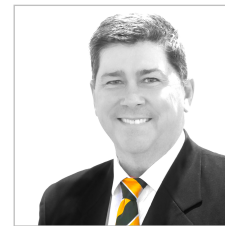

## OUR TINGIRA ...

### Growing and still Reuniting

“ I'm extremely pleased to be invited once again to provide a report as part of the Tingira Association's 2019 Annual Report. The challenges of COVID-19 will have a significant impact on us all in the early and later parts 2020, I trust all of you are taking the necessary precautions and keeping yourselves healthy.

Once again, 2019 has been a very positive and progressive year for the Association. I note with some pleasure, that 2019 has seen the greatest increase in our membership since 2014. An excellent outcome! From my perspective, this characterises very positively the hard work and dedication of our National Executive, Lance Ker and his team, including our LJRs represented across all states and territories. BZ and thank you to all concerned, you're doing a great job on our behalf.

I have also been watching with great interest the number of JR intake reunions and other connections enabled by the Tingira Association, particularly the Facebook site. I recently had a conversation with a Warrant Officer, now retired, who was an important part of a Ship's Company I had the privilege to command too many years ago now. He is a man I trusted and respected then and that continues to be the case today. It became very clear to me during our discussion that, despite now being retired for a number of years, his ongoing active support for the men and women who worked for and with him during our time together is inspiring. Our discussion was littered with the many actions he continues to take in support of our then ship's company. This is a clear example of the culture instilled in us all during our service and it is important that we continue to cherish and nurture that culture in our post service life. Nobody knows what a veteran has been through better than another veteran and talking is a great way to move forward!

With 2019 behind us, we now look forward to an exciting 2020. Regrettably, but necessarily in my view, our planned reunion in W.A. to celebrate the 60<sup>th</sup> (Diamond) anniversary of the formation of the JRTE had to be cancelled. Our National President and his Executive made this difficult call based on the need to focus on the wellbeing of our membership. The COVID -19 pandemic has clearly driven the need to prioritise our membership health and safety above all else. Disappointing I know, for all of us, including the Executive and Committees who worked so tirelessly to make the reunion a success. 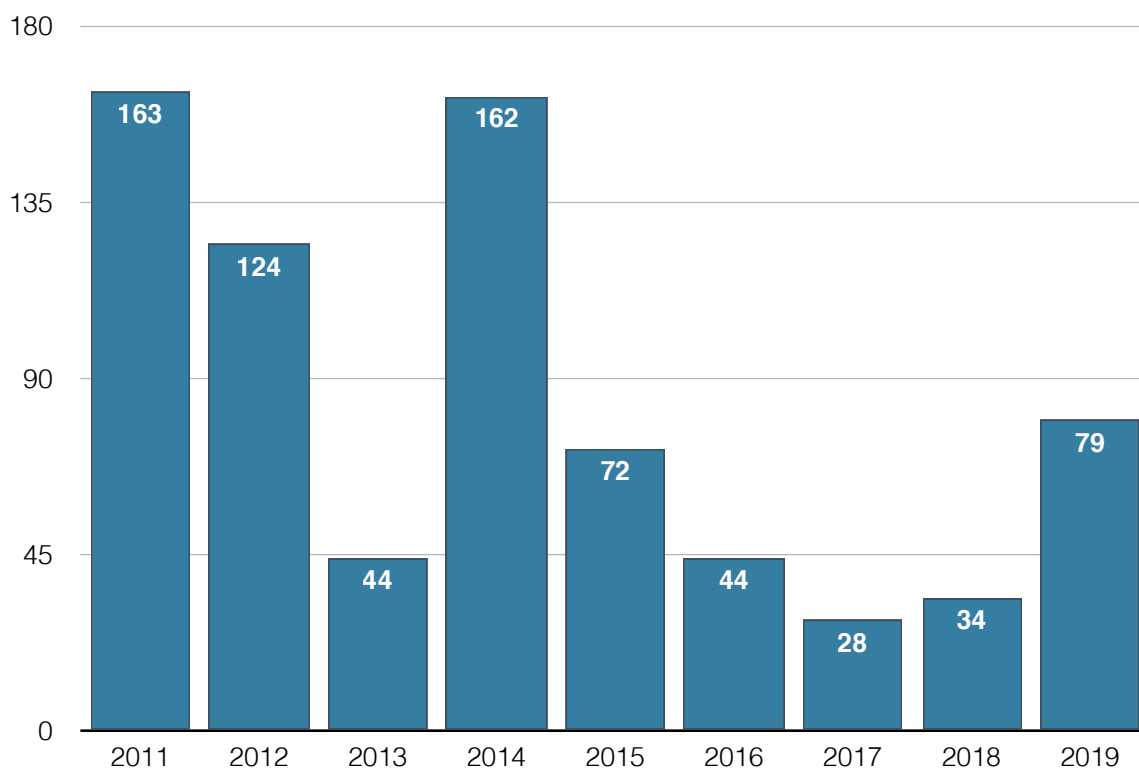

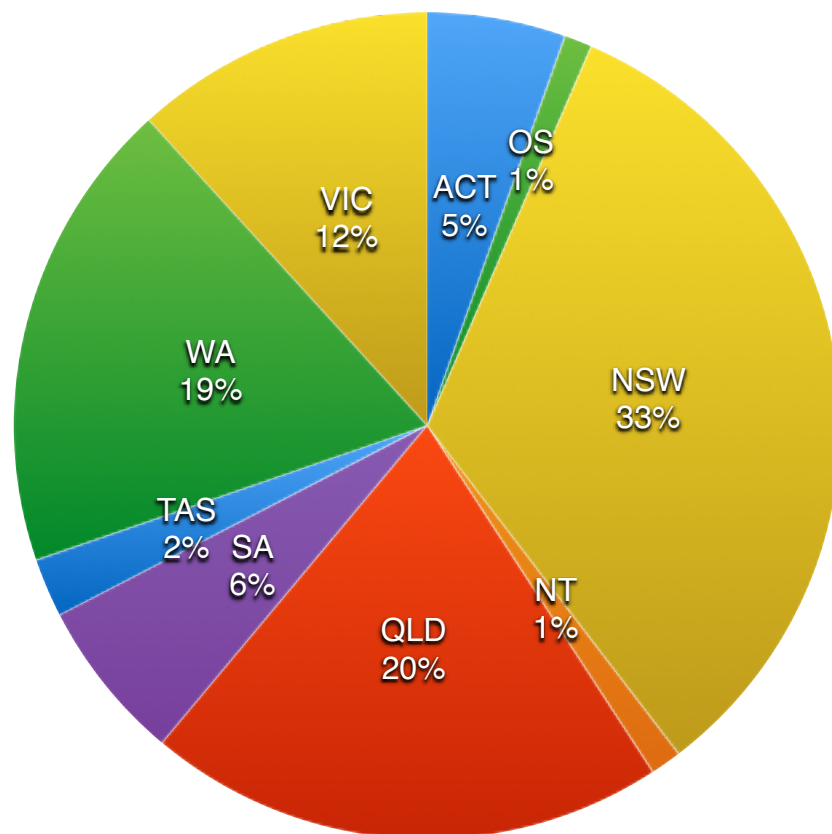

# Merchandise STATUS

## Income

Tingira Australia Association has membership and merchandise as the two major sources of income. Grants are sometimes applied for special projects and donations are received occasionally from members, charities and other organisations.

Merchandise sales were above average on past years with the announcement of the 2020 JR Reunion. Special merchandise products for the reunion were offered as once only order and price, the association is presently not in a position to carry large amounts of limited stock items. Sales and stocktake figs below as of 1st January 2020.

Foundation Life Membership of 2020 is in final phase as we approach our 10 year anniversary on 1st January 2021. This status of 'Foundation Life Membership' will cease at the end of June 2021. Sales for Foundation and General Memberships over the past 12 months with the introduction of auto renewal to General members with current credit cards is now in place and has been on target with the annual average.

April 2020 - The recent late cancellation of the proposed 2020 JR Reunion, with financially large amounts of deposits for services booked need to be sought, we have many unrecoverable costs in the process, followed by a difficult refund process back to members over the following months. The association will seek grants and donations during the remainder of 2020 with some sell on effect of left over reunion merchandise.

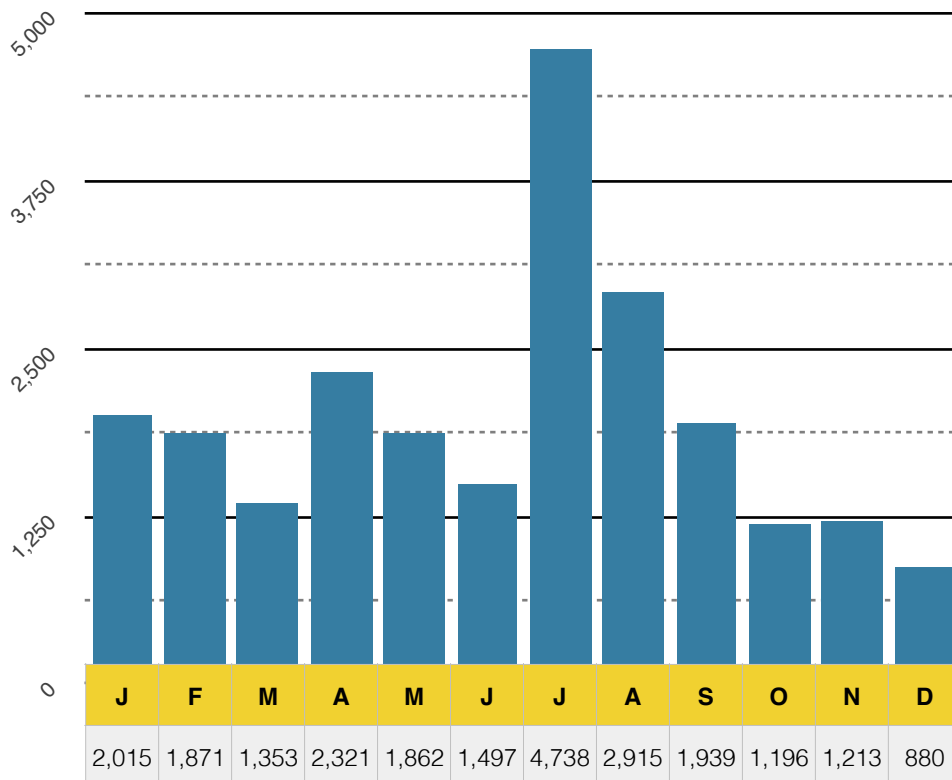

The Tingira website and communication via website will continue in the present formats in use.

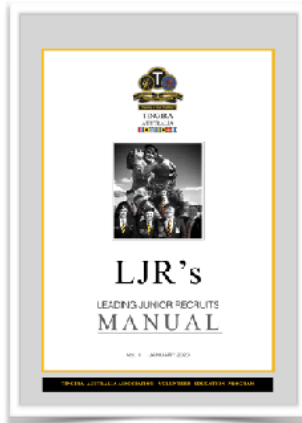

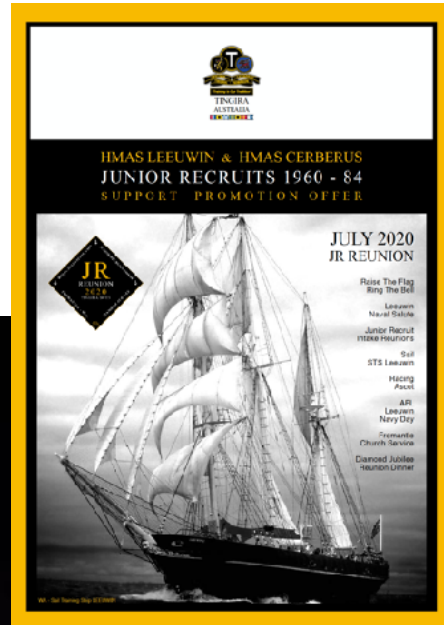

# FINANCIAL Statements

## Compilation Report

---

### TINGIRA AUSTRALIA ASSOCIATION INC. For the year ended 31 December 2019

We have compiled the accompanying special purpose financial statements of TINGIRA AUSTRALIA ASSOCIATION INC., which comprise the balance sheet as at 31 December 2019, the profit and loss for the year then ended, a summary of significant accounting policies and other explanatory notes. The specific purpose for which the special purpose financial statements have been prepared is set out in Note 1.

#### 1. Management Committee's Responsibility

The Management Committee of TINGIRA AUSTRALIA ASSOCIATION INC. are solely responsible for the information contained in the special purpose financial statements and have determined that the significant accounting policies adopted as set out in Note 1 to the financial statements are appropriate to meet their needs and for the purpose that the financial statements were prepared.

#### 2. Our Responsibility

On the basis of information provided by the Committee of TINGIRA AUSTRALIA ASSOCIATION INC., we have compiled the accompanying special purpose financial statements in accordance with the significant accounting policies adopted as set out in Note 1 to the financial statements and AAPS 315 - Compilation of Financial Information.

## Notes to the Financial Statements

---

### TINGIRA AUSTRALIA ASSOCIATION INC. For the year ended 31 December 2019

#### 1. Statement of Significant Policies

The Committee have prepared the financial statements on the basis that the Association is a non-reporting entity because there are no users dependent on general purpose financial reports. This financial report is therefore a special purpose financial report that has been prepared in order to meet the needs of members.

The financial report has been prepared in accordance with the significant accounting policies disclosed below which the Committee have determined are appropriate to meet the needs of members. Such accounting policies are consistent with the previous period unless stated otherwise.

The financial statements have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes. The accounting policies that have been adopted in the preparation of this report are as follows:

##### 1.(a) Income Tax

The Association is of the opinion that it is not subject to income tax.

##### 1.(b) Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned on a first-in, first-out basis and include direct materials, direct labour and an appropriate proportion of variable and fixed overhead expenses.

##### 1.(c) Property, Plant and Equipment

Property, plant and equipment are carried at cost, independent of the Committee's valuation. All assets, excluding freehold land and buildings, are depreciated over their useful lives to the Association.

Increases in the carrying amount arising on revaluation of land and buildings are credited to a revaluation reserve in the equity. Decreases that offset previous increases of the same asset are charged against fair value reserves directly in equity; all other decreases are charged to the profit and loss. Each year the difference between depreciation based on the revalued carrying amount of the asset charged to the profit and loss and depreciation based on the asset's original cost is transferred from the revaluation reserve to retained earnings.

The carrying amount of plant and equipment is reviewed annually by the Committee to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the asset's employment and subsequent disposal. The expected net cash flows have not been discounted in determining recoverable amounts.

##### 1.(d) Employee Benefits

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs.

##### 1.(e) Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at reporting date.

##### 1.(f) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.



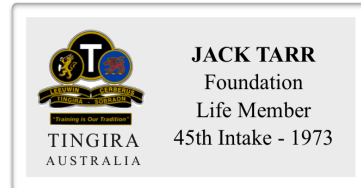

**Wednesday 18 March 2020** - Tingira Australia Association national committee, convened an extraordinary meeting to pass a motion with reference towards 'conducting or cancel' the 2020 JR Reunion due to the outbreak of the worldwide COVID-19 virus situation and the possible consequences.

"It is with great regret that I announce that the motion was 'passed unanimous' by the committee yesterday, the '2020 JR Reunion is cancelled'. I feel for our organising committee and the many boys who intended travelling from overseas and interstate for this joyful occasion. One group of boys were about to depart for Perth on 'little red postie motor bike scooters' via a trip around the Australian coastline.

The demographic of the 55 - 75 age group within our Tingira group, with possibility of well over a 1,000 persons gathering over the five days of events, puts the Tingira community in the high risk category and way outside the government number recommendations. The decision was made less complicated as the Navy and Defence base Leeuwin, are now not open to accommodating a large crowd under the circumstances. A new announcement of the 100 person crowd control was presented nationally by the Prime Minister, Scott Morrison, on Wednesday just to add more complexity to future large group event situations".
