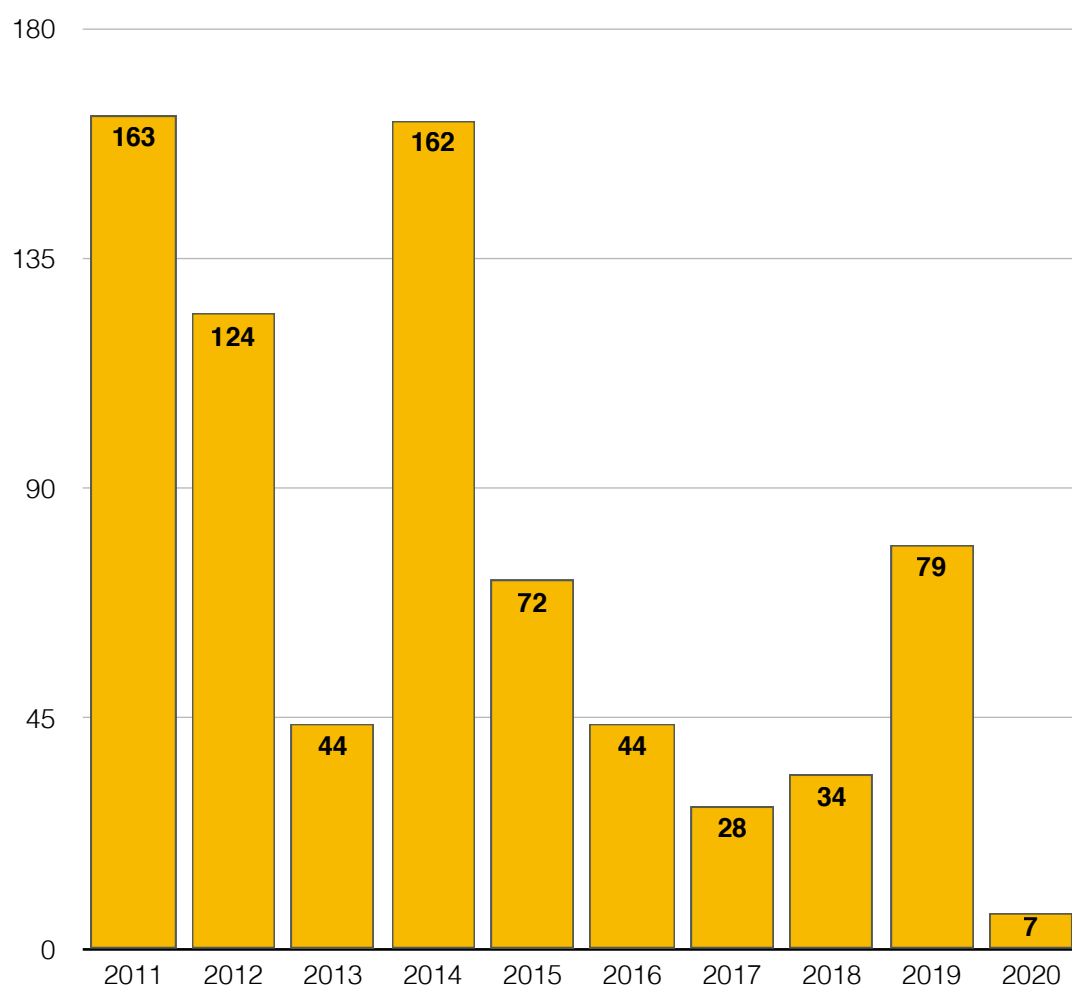

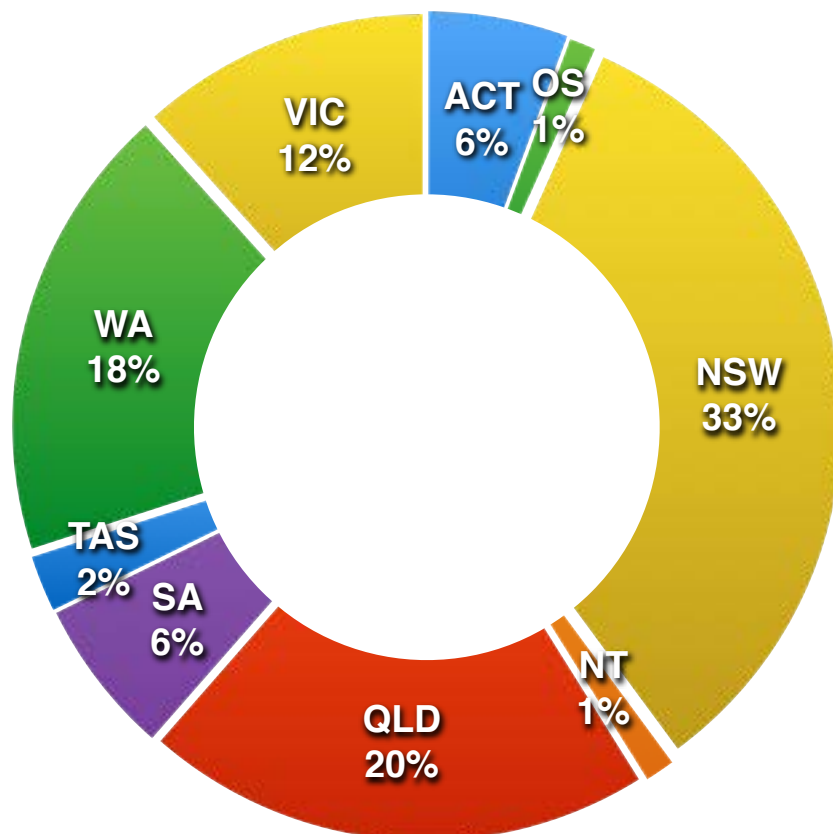

Tingira Australia Association website is the major source of communication with Members, Associates and supporting Friends. Our Media, History, Membership and Merchandise is now completely embedded into the one website. The 2020 JR Reunion website was closed down after the final refunds were processed in late September.

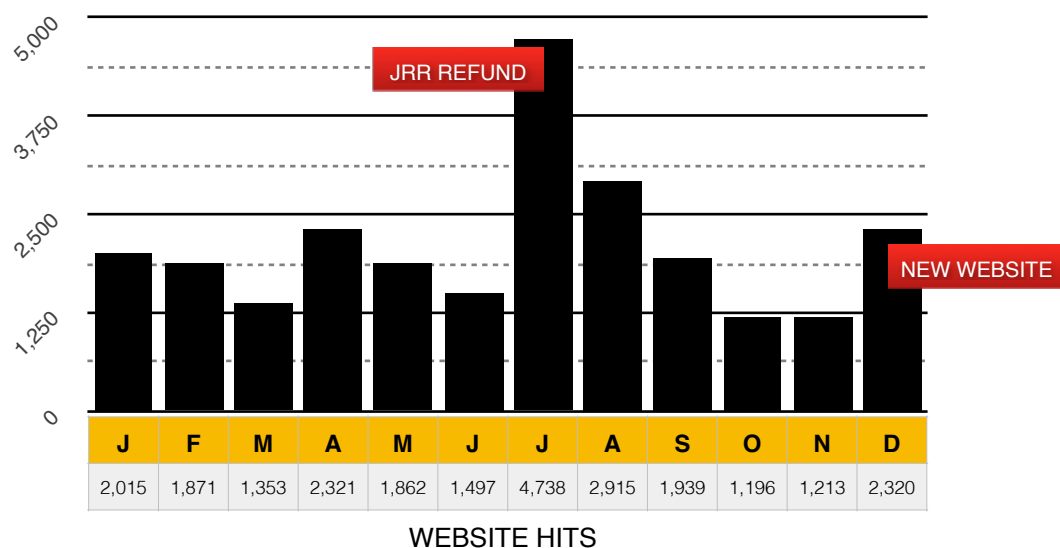
Membership email database continues to grow, however the number of email BOUNCE BACKS was over 50% in 2020, very concerning as an effective form of communication. The committee decided mid year, it was time to upgrade the Tingira website, take on new technologies for emails, membership data base and modernise the merchandise purchase systems for interstate and international financial transactions.

Sydney based, Copeland Creative agency, were sourced and able to offer their services to rebuild the website and deliver all the updated requirements to meet possible end of year launch. MTL design (Arizona, USA), our website host for past nine years, were very professional in liaison with Copeland Creative and the transfer of data and website backend coded in harmony during the transition period.

Website traffic for the year was above average, with cancellation of the 2020 JR Reunion and then the rollout of the refund process. The new website launch in Canberra mid November was successful function, co inside with a VoicePipe Christmas issue launch. Web click-on hits were back to a normal range by early December and no website problems were encountered, truly amazing!

The new merchandise and membership database systems inside the website backend will allow for greater control and easy access by the Secretary (webmaster). Secretary has also received website training sessions to enable access for update of front page and immediate media release information.

The new website has come at an economical monthly rate, better than expected. Committee is pleased with the update and the future merchandise prospects as our complete communication system to members will be tested in the first half of 2021. Committee members will have new emails in first qtr 2021, all with the new tingira.org prefix linked into our website account. The commercial 'Xero' accounting system will be adjusted to 'level one' in April 2021 with a 50% reduction on the monthly cost, as we do not envisage a turnover over \$100k for 2021 FY.



Merchandise STATUS & SALES

Stock & Merchandise Sales

Tingira Australia Association has membership and merchandise as the two major sources of income. Grants are sometimes applied for special projects and donations are received occasionally from members, charities and other organisations.

The financial report again includes the income and expenditure (refunds) for the 2020 JR Reunion. The income and costs of the reunion are spread over the 2019 and 2020 financial years. All refunds were returned minus 19 cents in the dollar to cover non refundable deposits and unrecoverable costs. Many members choose to donate portions of their refund as well to assist our position at the time.

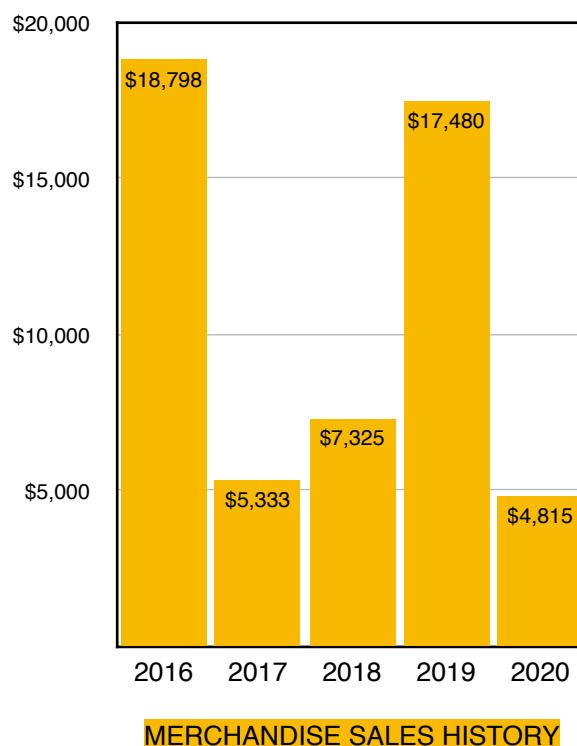
Merchandise sales were above average on past years with the announcement of the 2020 JR Reunion. Special merchandise products for the reunion were offered as once only order and price, the association is presently not in a position to carry large amounts of limited stock items.

Some reunion stock is left over on a 'run out' sale over the first quarter of 2021.

New items have been designed but not approved as 'grant' funding will now be sought to finish some print publications and to let the new committee make product decisions for the future requirements.

Membership will become the biggest focus in 2021. After the stay at home Anzac Day service which we expect to be repeated in 2021, this has a big effect on our merchandise income. With extra marketing efforts in early 2021, we expect to have members with the tingira cap with Foundation membership lapel on display for the 10th anniversary year celebrations.

NATIONAL COMMITTEE Meetings

MEETINGS

Tingira National Committee were not able to met 'Face to Face' this year, due to the Covid-19 national restrictions on interstate travel. Monthly meetings were held in the iPhone - FaceTime mode, the national hook up on the zoom system was not possible as several members had different systems.

Major decisions were 'put' to committee members by a new monthly report by the Secretary. All urgent matters were dealt at a 'day to day' level with a 48 hour response window by a 'circular motion' email. This communication proved to be very effective in circulation of information regarding performance, proposals, finance and new directions for the association.

The most important decisions were: cancellations of Tingira AGM, national ANZAC DAY March and the 2020 JR Reunion. The committee then set about to refocus and complete a satisfactory document for the 2020 - 2025 Strategic Plan for the incoming national Tingira Committee of 2021. This document was launched onto the new website at the December Canberra Christmas presentation. Secretary with assistance from some local Sydney members, completed the most difficult task of the reunion, refunds along with the delivery of the reunion merchandise packages.

AGM 2021 - The new Tingira National Committee will be elected with all positions vacant for members to fill. Financial records for both the 2019 and 2020 periods will be presented after the 2020 AGM was cancelled with the Covid 19 lockdown at short notice coming into effect late April.

The new Chairman's role was put, moved and approved at the 2018 AGM for the out going President to take this position as an option if desired. President, Lance Ker, will become the first 'Chairman' of the Tingira Australia Association when he vacates the Presidents role after the 2021 AGM.

1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009 [NSW]. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Income Tax

The Association is of the opinion that it is not subject to income tax.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

Non-current Assets

Non-current Assets include stock on hand.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

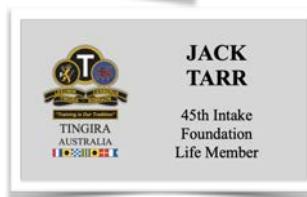
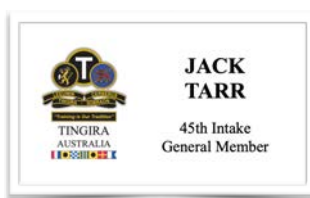

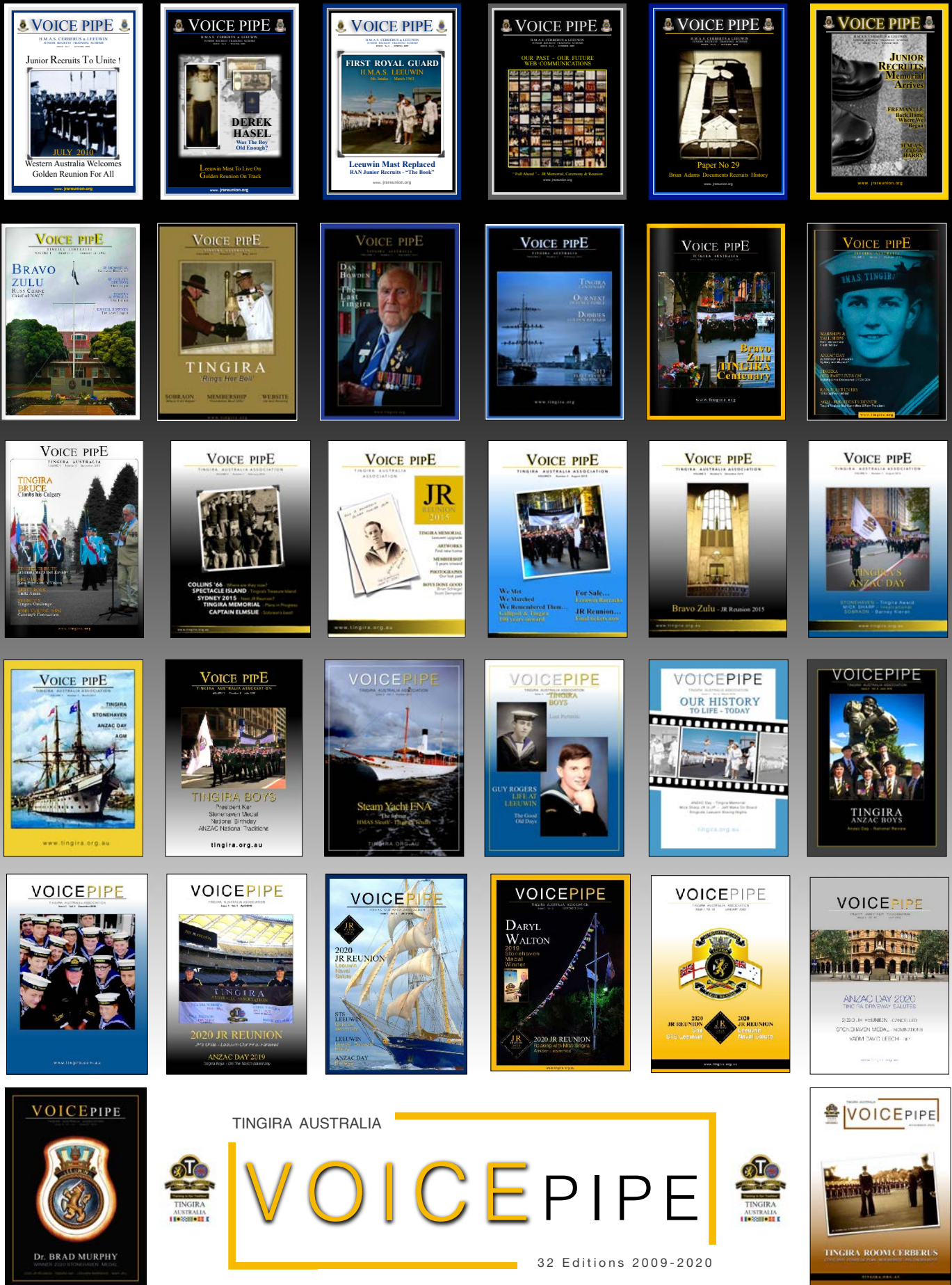
