## TINGIRA - YESTERDAY, TODAY AND TOMORROW ...

“ Our Tingira Secretary, Mark Lee, recently asked me to reflect on the first 15 years of our Tingira Association Australia (TAA). My initial thought was one of shock to realise that it has been 15 years since the TAA was formed. I then turned my thoughts to what the TAA has achieved in that relatively short period of time.

As many will know, I had the great privilege of leading the Royal Australian Navy (RAN) as the Chief of Navy for 3 years from 2008 to 2011. In a chronological or time-based sense, one of the greatest responsibilities of this office is to develop a strategic plan for the envisioned geopolitical future, manage our commitment to contemporary operations and safeguard our history and heritage. In an organisation as iconic as our RAN each of these timeframes are critically important. That said, I have always believed that an organisation such as our Navy stands, metaphorically, on the shoulders of those who have gone before us. Thus, managing our history and heritage has a special place in all that we do.

Not appreciating and preserving where we have come from can be fraught with danger and we need to do all that we can to preserve an understanding and provide ongoing acknowledgement of our history and heritage. It is not a concept of “nice to do”, it is central to our culture and warfighting capability. Our heritage is our hard edge. It is who we are and we must guard it well! Our heritage through the values, culture and commitment of those who have served and currently serve make the RAN what it is today and we must foster that heritage with great care. This is the reason I am

so pleased with the progress of the Association and its members over the first 15 years.

We are a small group of a little over 13,000 young boys who played an extremely important part in the development of our Navy in the 1960s, 70s and 80s as part of the Junior

Recruit Training Scheme. It is a part of our Navy history and will always be so. It follows then, in my view, that the TAA and its membership has a vital role in acting to preserve the understanding and knowledge of what occurred during this important and exciting period of our Navy's growth. We were a group of young boys drawn from an egalitarian society, trained and

readied to serve our nation to the best of our ability. Yes, there were some unwelcome issues which occurred during our training and it is important we learn from those. Equally important is that we celebrate the mateship, dedication and enthusiasm we learnt as JRs toward serving our nation both as we did then and now.

As I look at our TAA membership today, I see the many opportunities taken to rekindle those relationships and hold close that which we learnt as young men.

I have been extremely impressed with the way the TAA has developed over the past 15 years. A sailor's life is exciting and very special and central to that is the mateships that are developed in serving our nation at sea". **RC**

Joining the Association in 2011 as a Committee member, it was a great time for myself re-connecting with past, new and former shipmates of HMAS Leeuwin and the Royal Australian Navy family.

Looking back at 15 years down our Tingira road, I believe there are still many bright and active future years ahead of us. I've been honoured to be the National President for seven years and Chairman for the past five.

Our present Committee has great 'Vigilance and Devotion' to continue to navigate our course forward and upward. the upcoming JR Reunion in Perth is a prime example of 'Call the Hands'.

Since the Tingira's inception in 2010, after the 50 year JR Reunion in Perth, we have had many Committee combinations with a mixture of well bred JR's with some very rounded worldly experience in our ranks. This has propelled and forged this Association to where it is today, following on from our first generation of Tingira shipmates, the 'Tingira Old Boys Association' (TOBA).

Reflecting on many of our times with Mess Dinners at various military establishments, the Sydney home base at Rose Bay RSL club has supported the Association and the Tingira Memorial. We are honoured to be part of the Coral Sea commemoration annually with the America Australia Association in Canberra. Our 2015 reunion in Sydney was one of the greatest Reunions I've been a part of,

especially the James Craig Sail day and the Formal dinner where we honoured some 1st Intake JR's.

2020 was a bit of a downer with COVID-19, especially after the tireless work of the Committee from the Eastern States working with the West trying to bring us all together again.

We are a unique Association, coming together as 15-16-year-old sailor boys. This has only happened once before within the Royal Australia Navy's heritage. Clipper ship Sobroan, our first training ship HMAS Tingira from 1912 to 1927, and then us, the present second generation of RAN Tingira Boys from HMAS Leeuwin 1960-1984.

Unfortunately, I am lament to say we will never again see a program like the Junior Recruit Training Scheme again. due to the new world we live in today.

The JR's from the 1960s-80s have reached all levels of excellence with a few Admirals in our ranks and other outstanding achievements which are still coming through the current Australian Defence Force in expertise and experience, which all started on that Parade ground in East Fremantle. Our annual award of the 'Stonehaven Medal' is a prime example of who we are today in community and society.

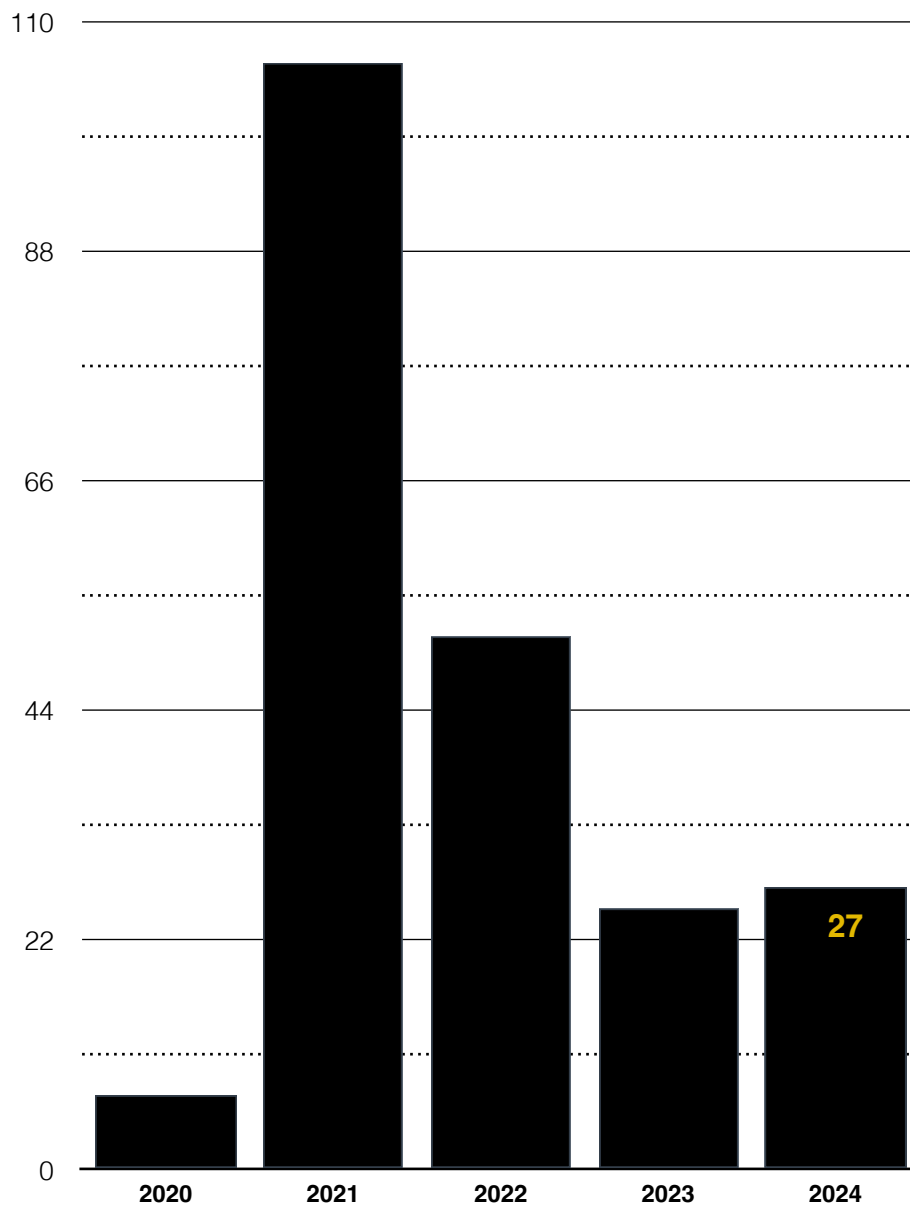

Many General Members have now upgraded to the Life Member status, they are not counted as new members.

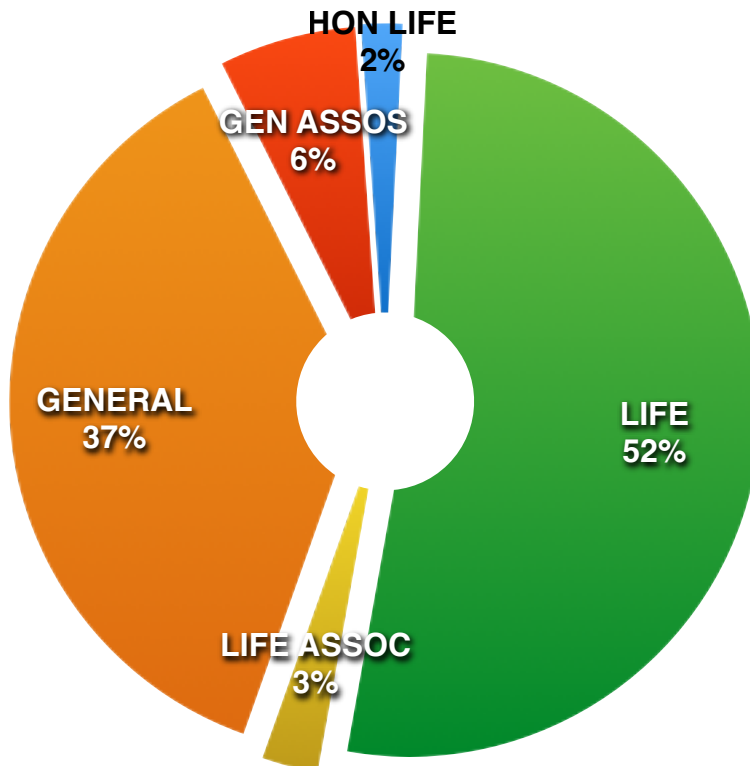

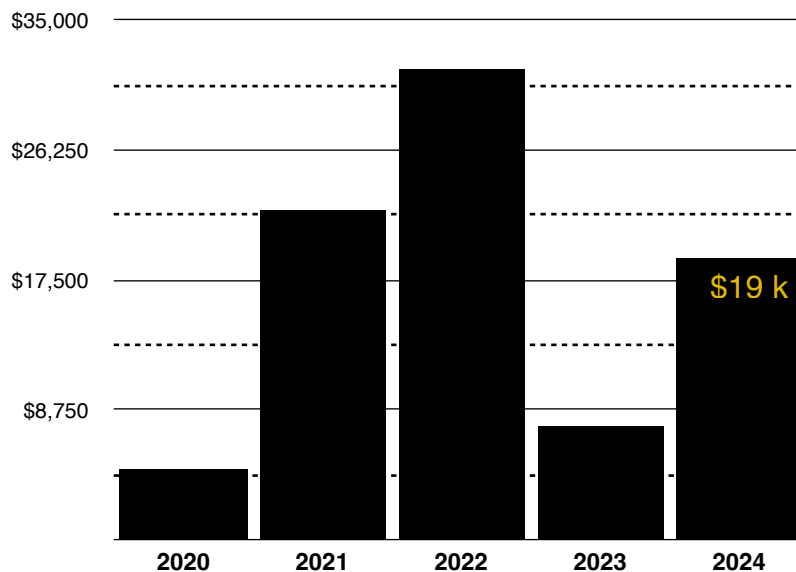

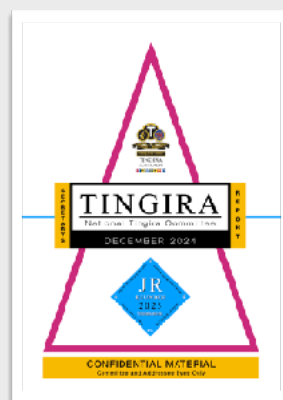

## Notes to the Financial Statements

### TINGIRA AUSTRALIA ASSOCIATION

For the year ended 31 December 2024

#### 1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act New South Wales. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

#### Income Tax

The Association is of the opinion that it is exempt and not subject to income tax.

#### Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

#### Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

#### Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

#### Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that out flow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash on Hand Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

#### Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

#### Leases

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset (but not the legal ownership) are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for that period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term. Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

#### Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

Financial Assets Investments in financial assets are initially recognised at cost, which includes transaction costs, and are subsequently measured at fair value, which is equivalent to their market bid price at the end of the reporting period. Movements in fair value are recognised through an equity reserve.

#### Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.
